TREE TRIMMING

Please remember to trim your trees that hang over the sidewalk. Walkers and bikers need to be able to use the sidewalk without having to duck. Thank you for your cooperation!

TRASH

This is a reminder that according to <u>Powell City Code</u>, all garbage and refuse containers shall not be placed outside the front of the residential property for pick up more than 24 hours before scheduled pick up. All garbage and refuse containers shall be removed to behind the building line of residential property within 24

hours of pick-up. Please do not leave your containers at the curb or in front of your house outside these 24-hour windows. Thank you!

EXTERIOR LIGHTS

Please be mindful if an exterior light on your house might be shining brightly into a neighbor's home at night. Please keep exterior lights pointed toward the ground and away from neighbor's windows, consider using a low watt bulb, and be mindful how motion sensor lights may impact other neighbors at night.

"Exterior lighting fixtures shall be so shaded, shielded, or directed that the light intensity or brightness shall not be objectionable to occupants or owners of surrounding areas. No more lighting than is necessary will be installed in order to reduce light pollution." - <u>Powell Code of Ordinances</u>, 1145.19(g)

COMPOSTING IN COLUMBUS

You even get free compost for your garden each year! The Compost Exchange can collect your food scraps via drop-off locations or curbside pick-up.
